



**DECISION OF THE PUBLIC AUTHORITIES BOARD OF THE
ECSEL JOINT UNDERTAKING 2020.50**

**Modifying decision PAB 2020.49 instructing the Executive Director
to launch the calls for proposals ECSEL-2020-1 IA, ECSEL-2020-2
RIA, ECSEL-2020-3-RIA and ECSEL-2020-4 CSA**

THE PUBLIC AUTHORITIES BOARD OF THE ECSEL JOINT UNDERTAKING,

Having regard to the Statutes annexed to Council Regulation (EC) No 561/2014 of 6 May 2014 on the establishment of the ECSEL Joint Undertaking, and in particular Article 12 of the Statutes of the Regulation,

WHEREAS:

- (1) The Executive Director should manage the launch of Calls of Proposals within the mandate given by the Public Authorities Board;
- (2) The Public Authorities Board should approve the launch of Calls for Proposals;
- (3) As the Governing Board has amended the work plan 2020 and especially the criteria for evaluation of projects proposals (decision GB 2020.141 adopted on 20.04.2020), it is adequate that the PAB confirms its instruction to the Executive Director to launch the above-mentioned calls for proposals on the basis of the amended work plan;
- (4) Call ECSEL-2020-3-RIA is now ready to be launched, the PAB should therefore instruct the Executive Director to launch it;

HAS ADOPTED THIS DECISION:

Article 1

The Executive Director of the ECSEL Joint Undertaking is hereby instructed to launch the ECSEL calls for proposals:

- ECSEL-2020-1 IA,
- ECSEL-2020-2 RIA,
- ECSEL-2020-3 RIA,

- ECSEL-2020-4 CSA,
further to the adoption of the following decisions:

- The Work plan of the ECSEL Joint Undertaking for 2020: Governing Board decision ECSEL GB 2020.141, amending decision ECSEL GB 2019.132;
- The rules on evaluation and selection of proposals: Public Authorities Board decision ECSEL PAB 2018.31;

Article 2

The Executive Director shall make available on the date of publication of the Call the Guide for Applicants related to the Call for Proposals of the ECSEL Joint Undertaking.

Article 3

The ECSEL Call for Proposals shall be published at least:

- on the website of the ECSEL Joint Undertaking;
- on the relevant websites of the Joint Undertaking's members,
- on the H2020 single portal for participants (Funding and Tenders Portal).

Article 4

For sake of legal clarity, Decision ECSEL PAB 2020.49 shall be repealed and replaced by this Decision.

This Decision shall enter into force on the date that follows the day of its adoption.
